Instruction is also given on style, bows and courtesies, the use of the hat, and the ballroom menuet ordinaire as given by Pierre Rameau. Book Two adds the slow Seventeenth-Century French Courante; A survey of the 56 dances extant to music by J.B. Lully with their airs and some of the more virtuosic, theatrical step-units in

notation; Louis Pécour's ballroom dance Aimable Vainqueur (1701 in six pages of dance notation with a five-part score of André Campra's music from Hésione (1700) and an updated bibliography.
